  - (b) Certificate / List of the **similar works** showing works with cost executed in various departments and public sectors must be submitted.
  - (c) Latest Tax Returns and PAN and EPF and GST registration.
  - (d) **Valid Registration Certificate** from <u>MES/PWD/CPWD/Railway/Cantt Board</u> of the appropriate class/Category. Contractors not enlisted with the cantt Board will be required to enclosed necessary documents to prove their eligibility as given above including <u>affidavit of 100 rupees</u> stamp for no recovery outstanding or any dispute <u>like blacklisted</u> from the concerned department.
  - (e) List of technical staff employed.
  - (f) For items at S.No. 01,03,04,05,06,09,10 and 12 the Integrity Pact has to be signed by the participating firm/agency and must be submitted with prequalification documents. Non-signing/non-uploading of the signed Integrity pact at prequalification stage will lead to disqualification in Technical evaluation.
  - (g) The Cost of Tender Form is deposit only accepted in the form of e-Chhawani m-Collect challan, in respect of cost of tender form. Which is non refundable.
  - (h) The Earnest Money/Security deposit is only accepted in the form of **FDRs/Bank guarantee**.
  - (i) Any bids <u>received without any of the above</u> enclosures and after the due date and time, <u>will be rejected</u> summarily.
