 - (d) Minimum 3 years experience in similar work.
 - (e) Minimum 3 work orders of similar work.
 - (f) Bidder should have a local office in Jabalpur. Address proof must be provided.
 - (g) The firm must have recognition from Animal Welfare Board of India.
 - (h) The cost of Tender Form is accepted only in the form of e-Chhawani m-Collect challan, which is non-refundable.
 - (i) The Earnest Money/Security deposit is only accepted in the form of FDR.
