  - The Bidders should have a Service Support Centre with spare part(s) of the machine of availability on site. The declaration certificate is submitted by bidder.

  - The firm must have ISO certificate.
  - Last 3 years IT return.
  - The firm must produce the bank solvency letter from their bankers for an amount of minimum 1 crore is not 6 months older.
  - The bidder / their authorized representative should not have been blacklisted in past for principal's products by any municipal organization/ Govt./ Semi.Govt./in India.
