  - The Contractor/Agency must have minimum one work order for the supply/hiring of tent material in previous 03 years.
  - GSTIN
  - Labour Registration.
  - Firm registration alongwith affiliation of Tent and light Dealer association.
  - The applicant should have Revenue/bank solvency of Rs. 10lakh.
  - Authority letter (In case documents signed by the authorized representative)
  - Balance sheet of contractor/agency of last year.
  - Registered Local Address proof of office of the participating contractor/agency.
  - Affidavit of declaration regarding contractor/agency is not blacklisted by any Govt. agency on the date of submitting the tender.
- Tenderers have to submit original copies of Tender fee and EMD, and must bring original documents of eligibility criteria mentioned above at the date and time of opening of

prequalification for verification, mentioned against the tender for which the contractor has placed his bid.

Tendered should ensure that the bids be uploaded/ applied before closing date and time.
