2. Eligibility criteria for contractor are as follows:-
 - (a) One Solvency Certificate/Bank Guarantee for 50% of the cost of work.
 - (b) Certificate / List of the similar works showing works with cost executed in various departments, private and public sectors must be submitted.
 - (c) Latest Tax Returns PAN,EPF,ESIC and GST.

- (d) Valid Registration Certificate from MES/PWD/CPWD/Railway/Cantt Board of the appropriate class/Category. Contractors not enlisted with the cantt Board will be required to enclosed necessary documents to prove their eligibility as given above including affidavit of 100 rupees stamp for no recovery outstanding or any dispute like blacklisted from the concerned department.
- (e) List of technical staff employed.
- (f) The cost of tender form is only accepted in the form of e-Chhawani mCollect challan. Which is non refundable.
- (g) The Earnest Money/Security deposit is only accepted in the form of FDRs/Bank guarantee.
- (h) Any bids received without any of the above enclosures and after the due date and time will be rejected summarily.
- (i) For items at S No. 1,2,4,5,8,9,10,11,12,14,20 the integrity pact has to be signed by the participating firm/agency and must be submitted with prequalification documents. Non signing/non uploading of the signed Integrity pact at prequalification stage will lead to disqualification in Technical evaluation.
3. Bidders have to submit original copies of tender fee and EMD, and must bring original documents of eligibility criteria mentioned above at the date and time of opening of prequalification for verification, mentioned against the tender for which the contractor has bid.

Conditional tenders shall not be accepted. The CEO / Cant Board **reserve the right to accept or reject any application** if found to be lacking in any of the above requirements. The Board / undersigned reserve the right to accept or reject any or all the tenders without assigning any reason thereof.
